

## Vacation Plat Description

Being a portion of Baltimore Street and a portion of alleys in the Village of Mark Center located in the Northeast quarter (1/4) of the Southeast quarter (1/4) of Section 21, Township 4 North, Range 2 East, Mark Township, Defiance County, Ohio.

Beginning at the northwest corner of Lot No. 12 of the Kyle and Anderson's Addition to the Village of Mark Center, as recorded in Plat Volume 4 Page 62 of the Defiance County Recorder's Record of Plats; thence southerly of the west line of Lot 12 and Lot 11, a distance of 120.00 feet to the southwest corner of Lot No. 11; thence easterly on the southerly line of Lot 11, a distance of 120.00 feet to the southeast corner of Lot No. 11; thence northerly on the east line of Lot No. 11 & Lot 12, a distance of 120.00 feet to the northeast corner of Lot No. 12; thence easterly, 16.5 feet to the northwest corner of Lot No. 5; thence southerly on the west line of Lot No. 5 and Lot No. 6, a distance of 120.00 feet to the southwest corner of Lot No. 6; thence easterly on the southerly line of Lot No. 6, a distance of 120.00 feet to the southeast corner of Lot No. 6; thence southerly, 16.0 feet to the northeast corner of Lot No. 7; thence westerly on the northerly line of Lot No. 7, a distance of 120.00 feet to the northwesterly corner of Lot No. 7; thence southerly on the west line of Lot No. 7 and Lot No. 8, a distance of 120.00 feet to the southwest corner of Lot No. 8; thence westerly, 16.5 feet to the southeast corner of Lot No. 9; thence northerly, on the easterly line of Lot No. 9 and Lot No. 10, a distance of 120.00 feet to the northeast corner of Lot No. 10; thence westerly on the northerly line of Lot No. 10, a distance of 120.00 feet to the northwest corner of Lot No. 10; thence southerly of the west line of Lot No. 10 and Lot No. 9, a distance of 120.00 feet to the southwest corner of Lot No. 9; thence westerly 60.00 feet to the southeast corner of Lot No. 64; thence northerly of the east line of Lot No. 64, a distance of 120.00 feet to the northeast corner of Lot No. 64; thence westerly on the north line of Lot No. 64 and Lot No. 63, a distance of 124.00 feet to the southwest corner of Lot No. 63; thence southerly on the west line of Lot No. 63, a distance of 120.00 feet to the southwest corner of Lot No. 63; thence westerly, 16.5 feet to the southeast corner of Lot No. 62; thence northerly on the east line of Lot No. 62, a distance of 120.00 feet to the northeast corner of Lot No. 62; thence westerly on the north line of Lot No. 62 and Lot No. 61, a distance of 124.00 feet to the northwest corner of Lot No. 61; thence northerly 16.0 feet to the southwest corner of Lot No. 44; thence easterly on the south line of Lot No. 44 and Lot No. 43, a distance of 124.00 feet to the southeast corner of Lot No. 43; thence northerly on the east line of Lot No. 43, a distance of 120.00 feet to the northeast corner of Lot No. 43; thence easterly 16.5 feet to the northwest corner of Lot No. 42; thence southerly on the west line of Lot No. 42, a distance of 120.00 feet to the southwest corner of Lot No. 42; thence easterly on the south line of Lot No. 42 and Lot No. 41, a distance of 124.00 feet to the southeast corner of Lot No. 41; thence northerly on the east line of Lot No. 41, a distance of 120.00 feet to the northeast corner of Lot No. 41; thence easterly 60.00 feet to the point of beginning. The vacated portion of Baltimore Street and alleys herein described contains 0.726 acres more or less.
