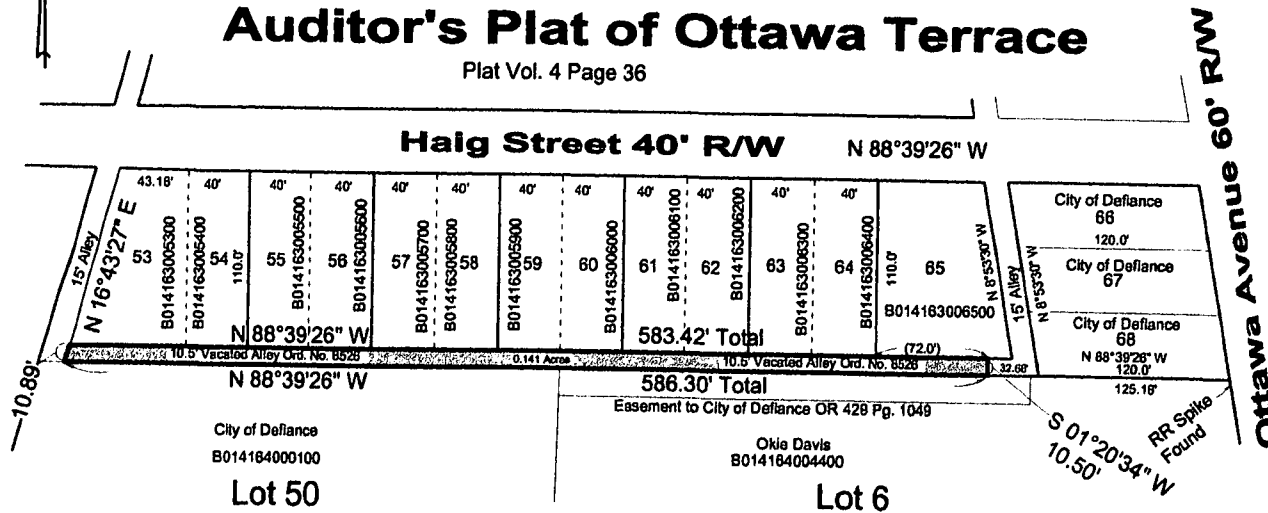


Vacation Plat of 10.50 feet alley in Auditor's Plat of Ottawa Terrace

Commencing at a railroad spike found at the intersection of the line common to said Lot No. 6 of Lots between Ottawa & Karnes Avenue (Plat Vol. 4 Page 36) and the westerly line of Ottawa Avenue (60' R/W); Avenue (Plat Vol. 4 Page 31) and Lot No. 6 of Ottawa Terrace (Plat Vol. 4 Page 36) and the southerly line of Lot No. 68, a distance of 152.66 feet to the point of beginning; thence North 88 degrees 39 minutes 26 seconds West, on the southerly line of a vacated 10.50 feet alley, beginning; thence continuing North 88 degrees 39 minutes 26 seconds West, on the southerly line of a vacated 10.50 feet alley, (Ord. No. 8526), a distance of 586.30 feet to the easterly line of a 15 feet alley; thence North 16 degrees 43 minutes 27 seconds East, on said easterly line, 10.89 feet to the southwesterly corner of Lot No. 53 of Ottawa Terrace; thence South 88 degrees 39 minutes 26 seconds East, on the northerly line of said 10.50 feet alley, 583.42 feet, (passing a 5/8-inch iron pin found at 511.42 feet); thence South 01 degree 20 minutes 34 seconds West, 10.50 feet to the point of beginning. The vacated alley herein described contains 0.141 acres more or less.

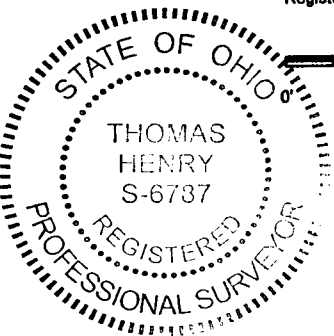
