


Description of land for: John & Richard Hoshock, 36.905 Ac.

Being a part of the Northeast quarter (1/4) of the Northeast quarter (1/4) of Section 5, Township 3 North, Range 5 East, Highland Township, Defiance County, Ohio and which is more particularly described as follows;

Beginning at an iron pipe found at the Northeast corner of the Northeast quarter (1/4) of Section 5;

Thence South 1°33'03" West, (assumed bearing for the purpose of this description), on the East line of the Northeast quarter (1/4) of Section 5, one thousand five hundred forty-four and seventy-three hundredths (1544.73) feet to an iron pin found;

Thence North 89°00'34" West, three hundred forty-three and eighty-three hundredths (343.83) feet to a point in the centerline of Defiance Ayersville Pleasant Bend Road;

Thence North 53°25'33" West, on the centerline of the Defiance Ayersville Pleasant Bend Road, five hundred twenty-three and fifty-seven hundredths (523.57) feet to a mag nail set;

Thence North 37°33'09" East, on a new division line, one hundred fifty-eight and ten hundredths (158.10) feet to an iron pin and cap set;

Thence North 6°17'54" West, on a new division line, two hundred eleven and forty-eight hundredths (211.48) feet to an iron pin and cap set;

Thence North 89°04'26" West, on a new division line, five hundred thirty-seven and sixteen hundredths (537.16) feet to a mag nail set on the centerline of the Defiance Ayersville Pleasant Bend Road;

Thence North 53°26'45" West, on the centerline of the Defiance Ayersville Pleasant Bend Road, ninety-two and eighty-two hundredths (92.82) feet, to a point established at the intersection of the centerline of the Defiance Ayersville Pleasant Bend Road and the West line of the Northeast quarter (1/4) of the Northeast quarter (1/4) of Section 5;

Thence North 1°22'41" East, on the West line of the Northeast quarter (1/4) of the Northeast quarter (1/4) of Section 5, eight hundred fifty-nine and eighty-six hundredths (859.86) feet to a point at the Northwest corner of the Northeast quarter (1/4) of Section 5;

Thence South 88°34'39" East, on the North line of the Northeast quarter (1/4) of Section 5, one thousand three hundred twenty-four and twenty-eight hundredths (1324.28) feet to the point of beginning.

Containing 36.905 acres of land more or less. Subject to all legal highways, easements, zoning regulations or restrictions of record.
