ORDER OF BUSINESS NO. 3 -- 2018 Twp budget - the fiscal officer presented:

- a) Bank Depository for township funds is presently the State Bank and Trust.
 - i) There is an agreement with the Township
 - ii) Said agreement was renewed by the Trustees in January 2013 and is in effect from November 25th, 2012 to November 24th, 2017.
 - (1) The agreement pledges the bank's assets to cover the Twp funds, which are on deposit at this institution.
 - (2) The fiscal officer is planning to move the money market funds to Star Ohio or re-negotiate interest rates paid on the money market with the State Bank.
 - (3) As of this session, the State Bank has agreed to meet and maintain the Star Ohio rates.
 - (a) Bank official Kristen Nusbaum emailed the Twp fiscal office that the State Bank will take the average monthly rate from the Star Ohio web page (of the previous month) and post that rate to Twp accounts for the next month.
 - (i) Dec Star Ohio monthly average used for January.
 - (ii) This was agreeable with the Fiscal office.
 - (4) Trustees concurred with this process all being desirous of keeping Twp money locally invested if fiscally reasonable.
 - (5) The fiscal officer is now working on the renewal security of deposit document, which requires the State Bank to protect the funds of the Twp which exceed the FDIC maximum deposits for protection.
 - iii) Twp investment status as of this session
 - (1) Note Township funds are invested in two accounts at the State Bank & Trust
 - (a) The primary checking account as of 12-31-17 was \$153,006.04
 - (i) 16 was \$117,266.04
 - (ii) 15 was \$198,678.30
 - (iii) 14 was \$230,861.49
 - (iv) 13 was \$229,973.57
 - (b) The money market account 12-31-17 was \$705,885.26
 - (i) 16 was \$705,533.38
 - (ii) 15- was \$705,180.70
 - (iii) 14 was \$704,861.21
 - (iv) 13 was \$704,828.21
 - (2) The decrease in the checking account is of concern. The fiscal officer recommends that Trustees bear in mind that the checking funds have decreased in three of the last five years. The money market is only slightly increased.
 - (a) This situation may affect future capital expenditures on road maintenance/road reconstruction & the ems rescue contact. The ems contract will expire on 12-31-2019.
 - **(b)** The general fund for the fourth straight year has expended more than its income Twp is using carryover funds. The average is around \$2k more or less exp v income.
 - (c) Trustees should refer to the mins of the 2017 sessions for details.
 - (3) The increase in the money market is simply the earnings from the year on our money market account. (very low interest less the 1%)- refer to section a above.
 - (4) Report Cash Fund Summary start of 2018 fiscal year carry over funds exhibit 3 -a
 - (a) This shows the Twp cash position as of the 1st, of January, 2018, prior to the approved 2018 amended certificate. The amended certificate includes anticipated revenue.

- d) Discussion -
 - As of the beginning of 2018 refer to explanation under agenda item "township investment status".
 - The road funds are being utilized as planned. With the continued use of OPWC grants (not to exceed the remaining 7 (2018-2024) year program average of \$25k per year, the Township is funded to continue its current road maintenance and repair program.
 - (1) Trustees should pay special attention if they intend to purchase replacement vehicles in 2018 regarding the comments noted in the twp investment status section of this agenda.

Chairman Shaffer requested approval of resolution #1 (01-2018) to adopt the 2018 Township Budget by fund line - object code. Resolution will allow the Fiscal Officer to move funds within fund account line's object code areas as he deems necessary in order to expedite payment. However, per the 07 state audit, Trustees must (as soon a practicable) move to accept the transfers within the lines between object codes at a regular scheduled Twp meeting.

All current Trustees as of November 2017's election will earn \$11,342.00 per annum beginning January 1, 2018. The Fiscal Officer (elected term beginning April 1, 2016) will earn \$18,717 starting January 1, 2018, per ORC.
 - ii) The Trustees and fiscal officer's salary for 2018 is based on an annual Township budget of between \$750,000 and \$1,500,000, per the ORC.
 - (1) rules passed in 2011 allow for Trustee salaries to be posted to special fund accounts with a statement

from Trustees noting their percent of work dedicated to those account fund projects.

- (2) Previously in compliance with the State Audit of 07, all Trustee wages and benefits had been posted to the general fund.
- (3) Our 2018 budget continues to post all elected salaries to the general fund.
- (4) By law the fiscal officer's salary still must be posted to the General fund -
 - (a) With the resolution is the pay schedule as published in the Ohio Township Association's newsletter "Grassroots" November issue.
 - (b) Discussion....there was none.

- (4) Trustees determined to increase all operator salaries by fifty cents (.50) per hour.
- (5) Trustees determined to increase the scheduler's salary by one dollar (\$1.00) per hour.
- (6) Trustees determined to deem Mike Daniels services as no long necessary. Trustees noted that there is not enough room in the maintenance building to conduct major mechanical repairs, nor does the Twp process the necessary tools and equipment. Therefore, the position of mechanic is not necessary. Further, Daniels has not worked for the Twp since July of 2016.
- (7) The chair asked for a motion to dismiss Micheal Daniels from the roster of part time employees of Defiance Twp.
