Minutes DEFIANCE TOWNSHIP TRUSTEES JANUARY 11TH, 2022 RE-ORGANIZATIONAL/BUDGET AND REGULAR MEETING

The Defiance Township Trustees met in special session (2022 budget, re-organization of the Board and general Township items) at the Defiance County Commissioners building – 500 Court St., 2nd floor conference room, in Defiance Township, Defiance, Ohio, on Tuesday January 11th, 2022 at 6:30 p.m.

The Chair instructed the clerk to call the roll. Answering as present were Daniel Peck, Diana Mayer, and Jason Shaffer; also present was Tim Houck, Township fiscal officer -Clerk. With all three members of the BOARD OF TRUSTEES having answered the roll, a quorum was declared.

Township employees present were: none.

ORDER OF BUSUNESS NO. 3 - 2022 Twp budget – fiscal officer

- a) Bank Depository for township funds is presently the State Bank and Trust.
 - i) There is an agreement with the Township
 - ii) Said agreement was renewed by the Trustees on January 23rd, 2018 and is in effect from November 24th, 2017 to November 25th, 2022.
 - (1) The agreement pledges the bank's assets to cover the Twp funds which are on deposit at this institution.
 - iii) Twp investment status as of this session -exhibit 3-a-1- a review of year end carryover.
 - (1) Note Township funds are invested in two accounts at the State Bank & Trust
 - (a) The primary checking account as of 12-31-21 was \$401,549.77
 - (i) 20 was \$275,973.50
 - (ii) 19 was \$273,908.10
 - (iii) 18 was \$191,004.79
 - (iv) 17 was \$153,006.04
 - (b) The money market account as of 12-31-21 was \$742,233.20
 - (i) 20- was \$741,635.19
 - (ii) 19- was \$735,919.98
 - (iii) 18- was \$718,881.87
 - (iv) 17- was \$705,885.26
 - (2) The fiscal officer notes that the increase in available funds is attributed to; the increase in revenues vs the anticipated revenue approved by the Budget Commission in our amended certificates, the use of 27k in opwc grant dollars and 88k of American Rescue Plan grant dollars (covid federal money).
 - (a) Budget commission anticipated income from first amended certificate was \$431,450.00
 - (b) Actual revenue was \$605,259.68 for 2021.
 - (i) The Twp also received bills on two of the elements of the Bowman Rd rebuild in 2021 that were less then was estimated. Trustees had budgeted \$180k and cash expenditures were \$120 more or less.
 - (c) Trustees are reminded that the ems rescue contract with the City of Defiance has expired as of 12-31-2019.
 - (d) The Township is presently awaiting a renewal proposal from the City.
 - (e) Current Twp commitments
 - (i) 88k to Ginter Rd rebuild with City in 2023
 - (ii) 130k for rebuild of 3rd mile of Bowman rd
 - (iii) 60k to road maintenance
 - (iv) 100k for general twp rd expenses
 - (f) The general fund decreased slightly less than \$3k.
 - (g) The fire fund increased slightly -4k +/-.
 - (3) The money market increased 1k +/-. The increase in the money market is simply the earnings from the year on our money market account. Now paying, per the agreement, a Star Ohio rate.
 - (4) Report Cash Fund Summary start of 2022 fiscal year carry over funds exhibit 3 –a-2
 - (a) This shows the Twp cash position as of the 1st, of January, 2022, prior to the approved 2022 amended certificate. The amended certificate includes anticipated revenue.

 - i) As of the beginning of 2022 Trustees should refer to explanation under agenda item "township investment status" above.
 - ii) The road funds are being utilized as planned. With the continued use of OPWC grants (not to exceed the remaining 3 (2022-2024) year program average of \$25k per year. The Township has committed 83k of opwc funds for the Ginter rd project to be done in 2023.
 - iii) The proposed 2022 budget contains funding to:
 - (1) Fund the 2022 amount for Bowman rd at \$130k- 1 mile section
 - (2) Continue the twp's road maintenance program with the Co. Eng. at an anticipated 60k- based on past history and discussion with the Engineer's office, and;
 - (3) allows for the continued normal twp annual road expenses of up to 100k.
 - (4) Partial funding has been designated for a truck replacement in 2023.

Chairman Shaffer requested approval of **resolution #1** (01-2022) to adopt the 2022 Township Budget by fund line – object code in the amount of \$1,683,485.74. Resolution will allow the Fiscal Officer to move funds within fund account line's object code areas as he deems necessary in order to expedite payment. However, per the 07 state audit, Trustees must (as soon a practicable) move to accept the transfers within the lines between object codes at a regular scheduled Twp meeting.

- (2) The Fiscal Officer will earn a salary of \$23,406.00 beginning January 1, 2022. The Fiscal Officer salary will be divided over the twelve months of 2022 in equal portion.
- ii) All salaries are based on an annual Township budget of between \$1,500,000.01 and \$3,500,000.00, per the ORC §§505.24 and 507.09.
 - (1) Our 2022 budget continues to post all elected salaries to the general fund.
