The Defiance Township Trustees met in special session (2021 budget, re-organization of the Board and general Township items) at the Defiance County Commissioners building – 500 Court St., 2<sup>nd</sup> floor conference room, in Defiance Township, Defiance, Ohio, on Tuesday January 12<sup>th</sup>, 2021 at 6:30 p.m.

The Chair instructed the clerk to call the roll. Answering as present were Daniel Peck, Diana Mayer, and Jason Shaffer; also present was Tim Houck, Township fiscal officer -Clerk. With all three members of the BOARD OF TRUSTEES having answered the roll, a quorum was declared.

## ORDER OF BUSUNESS NO. 3 - 2021 Twp budget - fiscal officer

- a) Bank Depository for township funds is presently with the State Bank and Trust.
  - i) There is an agreement with the Township
  - ii) Said agreement was renewed by the Trustees on January 23<sup>rd</sup>, 2018 and is in effect from November 24<sup>th</sup>, 2017 to November 25<sup>th</sup>, 2022.
    - (1) The agreement pledges the bank's assets to cover the Twp funds which are on deposit at this institution.
  - iii) Twp investment status as of this session -exhibit 3-a-1- a review of year-end carryover.
    - (1) Note Township funds are invested in two accounts at the State Bank & Trust
      - (a) The primary checking account as of 12-31-20 was \$275,973.50
        - (i) 19 was \$273,908.10
        - (ii) 18 was \$191,004.79
        - (iii) 17 was \$153,006.04
        - (iv) 16 was \$117,266.04
      - (b) The money market account as of 12-31-20 was \$741,635.19
        - (i) 19- was \$735,919.98
        - (ii) 18- was \$718,881.87
        - (iii) 17- was \$705,885.26
        - (iv) 16- was \$705,533.38
        - (v) 15- was \$705,180.70
    - (2) The fiscal officer noted that the increase is attributed in part to expenditures on the Bowman Rd rebuild of 2020 being less then Trustees had anticipated. Trustees had budgeted \$180k and cash expenditures were \$120 more or less.
      - (a) Trustees are reminded that the ems rescue contract with the City of Defiance has expired as of 12-31-2019.
        - (i) The Township is presently awaiting a renewal proposal from the City.
        - (ii) The City is billing the Township at the 2019 rates.
          - 1. Fire combat contract is based on the annual property valuation as prepared by the County Auditor. In 2020 the quarterly fee was \$15,812.98.
          - 2. The rescue service quarterly fee was \$13.500 + insurance collections.
      - **(b)** The general fund increased. (7.5k +/-).
      - (c) Trustees should refer to their appropriation status reports of the 2020 sessions for details.
    - (2) The money market increased 5.5k +/-. The increase in the money market is simply the earnings from the year on our money market account. Now paying, per the agreement, a Star Ohio rate.
    - (3) Report Cash Fund Summary start of 2021 fiscal year shows carry over funds exhibit 3 -a-2
      - (a) This shows the Twp cash position as of the 1<sup>st</sup>, of January, 2021, prior to the approved 2021 amended certificate. The amended certificate includes anticipated revenue.

- d) Discussion
  - i) As of the beginning of 2021 for fiscal officer's analysis refer to explanation under agenda item "township investment status".
  - ii) The road funds are being utilized as planned. With the continued use of OPWC grants (not to exceed the remaining 4 (2021-2024) year program average of \$25k per year, the Township is funded to continue its current road maintenance and repair program.
  - iii) The proposed 2021 budget contains funding to:
    - (1) Fund the 2021 amount for Bowman rd at \$190k.
    - (2) Continue the twp's road maintenance program with the Co. Eng. at an anticipated 60k- based on past history and discussion with the Engineer's office, and;
    - (3) allows for the continued normal twp annual road expenses of up to 100k.
    - (4) Funding has been designated for a truck replacement in 2022 if expenses are as planned.

Chairman Shaffer requested approval of **resolution # 1** (01-2021) to adopt the 2021 Township Budget by fund line – object code. Resolution will allow the Fiscal Officer to move funds within fund account line's object code areas as he deems necessary in order to expedite payment. However, per the 07 state audit, Trustees must (as soon a practicable) move to accept the transfers within the lines between object codes at a regular scheduled Twp meeting.

## ORDER OF BUSINESS NO. 4 - Wages for 2021

- a) Elected Officials
  - i) Pay is set by the State of Ohio by the Ohio Revised Code. The pay schedule for 2021 is as noted in the Ohio Twp Association's September 2020 newsletter. The ORC does not permit an increase in compensation in 2021 for Trustees in their current term who were elect prior to December 27<sup>th</sup>, 2018.
    - (1) Those Trustees will continue to earn \$11,342.00 per annum. The Trustee term beginning January 1, 2020 will earn \$11,948.00. Trustee salaries will be divided over the twelve months of 2021 in equal portion.
    - (2) The Fiscal Officer will earn a salary of \$19,717.00 beginning January 1, 2021. The Fiscal Officer salary will be divided over the twelve months of 2021 in equal portion.

- ii) All salaries are based on an annual Township budget of between \$750,000 and \$1,500,000, per the ORC, per the ORC §\$505.24 and 507.09.
  - (1) rules passed by the State legislature in 2011 allow for Trustee & Fiscal Officer salaries to be posted to special fund accounts with a statement from Trustees & the Fiscal Officer noting their percent of work dedicated to those account fund projects.
  - (2) Previously in compliance with the State Audit of 07, all wages and benefits have been posted to the general fund.
  - (3) Our 2021 budget continues to post all elected salaries to the general fund.
