ORDER OF BUSINESS NO. 3 -- 2015 Twp budget

- a) The fiscal officer reported that the Bank Depository for township funds is presently at the State Bank and Trust.
 i) There is an agreement with the Township
 - ii) Said agreement was renewed by the Trustees in January 2013 and is in effect from November 25th, 2012 to November 24th, 2017.
 - (1) The agreement pledges the bank's assets to cover the Twp funds which are on deposit at this institution.
 - iii) Twp investment status as of this session is:
 - (1) Note Township funds are invested in two accounts at the State Bank & Trust
 - (i) The primary checking account as of 12-31-14 was \$230,861.49
 - (ii) 13 was \$229,973.57
 - (iii) 12 was \$264,322.26
 - (iv) 11 was \$234,890.76
 - (v) 10 was \$102,384.79
 - (vi) 09 was \$72,038.35 -
 - (b) The money market account 12-31-14 Was \$704,861.21
 - (i) 13 was \$704,828.21
 - (ii) 12 was \$704,073.62
 - (iii) 11- was \$703,390.17
 - (iv) 10 was \$702,478.94
 - (v) 09-was \$701,441.77
 - (2) The increase in carryover is very minimal and is due to Trustee efforts to provide appropriate service within anticipated revenues.
 - (3) A report titled Fund Status states Twp funds as of the start of year as noted above. This report was presented as exhibit 3 –a and is on file.
- b) Adoption of the 2015 township Appropriations & budget
 - i) Exhibits # 3-b-1 "Approved Amended Certificate of Estimated Resources" from the County Auditor was discussed. The fiscal officer noted the amounts for the past several years:

d) A discussion followed:

- i) Trustees continue to be concerned with impending expenses of the Fire –rescue contract with the City of Defiance. In 2014 the City imposed an increase of \$24,000 for rescue services. A levy to cover this increase was defeated by voters in November 2014. Without additional revenue the Twp's fire fund will enter 2016 with only its anticipated 2016 revenue which is produced by the current levy. This amount has historically been \$77,000 more or less. It may require that general fund money will be needed to pay some expenses in 2015 (depending on the insurance collections) and it will most certainly require general fund dollars to supplement revenues from the current levy for the contract in 2016.
- ii) As of the beginning of 2015 the General fund is in good fiscal condition. The Twp is within \$2,000 plus or minus of revenue for the past several years. Ave. annual expenses are \$77 to \$79, At present we have at least a 3 year rainy day fund.
- iii) The road funds are being utilized as planned. With the continued use of OPWC grants (not to exceed the remaining 10 year program average of \$25k per year, the Township is funded to continue its current road maintenance and repair program.

Chairman Bakle requested approval of resolution # 1 to adopt the 2015 Township Budget by fund line – object code. Resolution will allow the Fiscal Officer to move funds within fund account line's object code areas as he deems necessary in order to expedite payment. However, per the 07 state audit, Trustees must (as soon a practicable) move to accept the transfers within the lines between object codes at a regular scheduled Twp meeting.

ORDER OF BUSINESS NO. 4 - Wages for 2015

- a) Elected Officials pay for 2015- the fiscal officer noted that:
 - Pay is set by the State Of Ohio by Ohio Revised Code. As noted in the Ohio Twp Association's December newsletter there will be no increase in the pay of elected officials governed by the ORC in 2015.
 - (1) The State rate remains --
 - (a) In 2015 trustees will receive \$10,288.00 (51.44 x 200 days -required state orc formula)
 - (b) fiscal officer pay rate (salary)
 - (i) is \$16,977
 - (2) rules passed in 2011 allow for Trustee salaries to be posted to special fund accounts with a statement from Trustees noting their percent of work dedicated to those account fund projects. Previously in compliance with the State Audit of 07, all Trustee wages and benefits had been posted to the general fund. Our 2014 budget continues to post all elected salaries to the general fund.
 - (3) By law the fiscal officer's salary still must be posted to the General fund -
 - ii) The Chair asked for discussion
 - (1) Trustees agreed at this time to continue to post their salaries to the General fund.

Chairman Bakle requested approval of resolution #2015- 02 wages of the Township's elected officers for 2015.

- b) Trustees than turned to address the Township employees pay for 2015
 - i) Trustees choose not to go into executive session for the purpose of discussing salaries for Twp employees
 - ii) Chairman Bakle asked for comments from the Trustees.
 - (1) Trustees determined that due to their concern with ever increasing expenses in Fire-safety and road projects that salaries will be frozen at the present \$13 per hour rate for Twp employees not in probationary status.
 - (2) Employees had received an .11 cent per hour increase at the beginning of 2012 taking non probationary employees to the present \$13 per hour. The probationary rate for new hires will remain at \$11.60 per hour for the probationary period of each new employee hired, (90 days more or less dependent upon end of month). Probationary employees will then be evaluated by Trustees to determine if the probationer is to be moved to the regular operators rate of \$13 per hour.
 - (3) The fiscal officer then reported that the proposal on the floor would reflect the following hourly rates should the proposal be adopted.

 - ii) Pay for members serving on the Twp Zoning Boards is \$20 per item per meeting and was established in 2008.

Chairman Bakle requested approval of resolution #2015-04 to set the wages of the Township's Zoning Bd of Appeals and Zoning Commission for 2015 at \$20.00 per item per meeting.

 - iii) Mrs. Mayer suggested the rate be raised to \$45 per day for meal reimbursement with proper documentation.

Chairman Bakle requested approval of resolution #2015-05 setting reimbursement allowance for meals in 2015 at \$45 per day.

- (1) Trustees verbally noted that mileage is paid for travel on Township business at the discretion of the Trustees.

 (4) The rate of navia \$22 per hour.

(1) The rate of pay is \$22 per hour.

iii) The expense is minimal. In 2014 the total was less than \$140.

- a) The Fire Rescue service contract for Def. Twp with the City of Defiance was modified per the City and Trustees as required approved the modification during the Twp's July meeting. The cost for rescue services was increased by \$24k.
 - i) In response the Twp Trustees placed a ballot issue before the voters (November 2014) of Twp precincts A & B where that service is rendered.
 - ii) See minutes from January 2014 forward to review history of a 2014 proposed fire-rescue service levy to be placed on the November 2014 ballot to cover the proposed City increase.
 - iii) The ballot issue was defeated in November.(a) 276 votes for 318 against.
 - iv) Trustee's in November voted to place the issue before the voters again in the May 2015 primary.

 v) Exhibit 13- was a packet from the County Prosecutor's office containing resolutions to be adopted – ballot language – a notice to the Board of Elections and a legal ad (to be run by the Board of Election" that once adopted by the Trustees the 1.1 mil levy for fire-rescue will be placed before the voters.

vi) To be adopted at this session is resolution 2015-10 "DECLARING IT NECESSARY TO LEVY AN ADDITIONAL 1.1-MIL TAX LEVY AND REQUESTING THE COUNTY AUDITOR TO CERTIFY THE TOTAL CURRENT TAX VALUATION OF THE DEFIANCE TOWNSHIP AND THE DOLLAR AMOUNT OF THE REVENUE THAT WOULD BE GENERATED BY THAT LEVY"..

Mr. Peck moved to employ both Mr. Kckibben and Mr. Rivers at the probationary rate of \$11.60 per hour with the probationary period to end April 30th, 2015.
