 - (2) The fiscal officer notes that the increase is attributed to Trustee efforts to accumulate funding for the multi-year re-build of Bowman Rd. The anticipated work in 2019 was not done by the project Engineer (Def. Co. Eng.) The fiscal officer recommends that Trustees bear in mind that the checking funds will decrease extensively during the 3 or 4 year rebuild if the engineer's project estimate of expenses is realized.
 - (i) It is quite probable that Trustees will need to transfer funds from this account to the checking to pay for the Bowman Rd. project.
 - (a) Trustees are reminded that the ems rescue contract with the City of Defiance has expired as of 12-31-2019.
 - (i) Per Trustee Peck the City will/is preparing a new proposal for Trustee consideration. Mr. Peck does not expect a large increase.
 - **(b)** The general fund increased. (11k +/-).
 - (i) The general fund increased by 13k from 2017 to 2018.
 - (ii) Previously this fund had four straight years of decline.
 - (c) Trustees should refer to their appropriation status reports of the 2019 sessions for details.
 - (3) The increase in the money market is simply the earnings from the year on our money market account. Now paying, per the new agreement, a Star Ohio rate.
 - (4) Report Cash Fund Summary start of 2019 fiscal year carry over funds exhibit 3 -a-2
 - (a) This shows the Twp cash position as of the 1st, of January, 2020, prior to the approved 2020 amended certificate. The amended certificate includes anticipated revenue.

 - i) As of the beginning of 2020 for fiscal officer's analysis refer to explanation under agenda item "township investment status".
 - ii) The road funds are being utilized as planned. With the continued use of OPWC grants (not to exceed the remaining 5 (2020-2024) year program average of \$25k per year, the Township is funded to continue its current road maintenance and repair program.
 - iii) The proposed 2020 budget contains funding to:
 - (1) Increase the 2020 amount for Bowman rd from 140k to 170 or 180k.
 - (2) Continue the twp's road maintenance program with the Co. Eng. at the past average of between 40 and 50k, and;
 - (3) allows for the continued normal twp annual road expenses of up to 100k.
 - (4) Funding has been designated for attorney's fees & findings/settlements.

 - (1) Those Trustees will continue to earn \$11,342.00 per annum. The Trustee term beginning January 1, 2020 will earn \$11,742.00. Trustee salaries will be divided over the twelve months of 2020 in equal portion.
 - ii) The Fiscal Officer will remain at an amortized salary of \$18,717.00 until the term ends on March 31, 2020. The Fiscal Officer will then earn an amortized salary of \$19,378.00 per annum base on an annual Township budget of between \$750,000 and \$1,500,000, per the ORC, per the ORC §\$505.24 and 507.09

- (1) rules passed in 2011 allow for Trustee salaries to be posted to special fund accounts with a statement from Trustees noting their percent of work dedicated to those account fund projects.
- (2) Previously in compliance with the State Audit of 07, all Trustee wages and benefits had been posted to the general fund.
- (3) Our 2020 budget continues to post all elected salaries to the general fund.
