With three (3) of three (3) members of the BOARD OF TRUSTEES having answered the roll, a quorum was declared.

- 1) The following financial reports provided to the Board were reviewed.
 - a) The Reconciliation for January noted a primary checking reconciliation balance of \$302,182.58 balance is minus the outstanding checks and Township investment funds & is taken from the Bank's monthly statement.
 - b) Receipt report:
 - i) Receipts for February (UAN software-) were \$29,074.68.
 - c) Payment reports:
 - i) Payments for February (UAN software-) were \$48,148.03.
 - d) The Cash fund summary through- February 27th, 2023 (UAN software) showed an "ending fund balance" of \$1,435,802.82.
 - i) The "cash available" for encumbrances (unencumbered fund balance- UAN software) was \$841,314.08.
 - e) Appropriation Status showed that through February 27th, 2023 (UAN software), 3% of the years' appropriations had been expended. All reports will be on file in the Fiscal Officer's office.
 - f) The fund status report (money market) showed:
 - i) The money market investment fund balance as of 02-27-2023 was \$1,164,209.49.
 - a) American Rescue Plan Act Def. Twp refer to mins of Twp sessions from July 2021 forward for details.
 - i) The Ohio Office of Budget Management (OBM) is managing the grants for many of Ohio's political subdivisions.
 - (1) As of this session the Def. Twp award is for \$176,505.54 + \$353.32 from OBM received in March 2022.
 - (a) Total expended to date is \$158,703.95. per resolution 10-2022 on the Bowman Rd rebuild 3rd mile segment.
 - (2) In the January 17th, 2023, Twp session Trustees approved resolution 10-2023 which designates use of the remaining grant funds on the 2023 Bowman Rd rebuild project 4th mile segment.
 - (a) Remaining funds in this fund line is \$32,154.00.
 - (3) The chair asked if there are any questions?
 - (a) The fiscal officer noted that once the funds have been expended the grant will be closed out.

- b) ODOT grant "Twp Stimulus Program". Funding provided by Federal government part of covid relief to states. See mins of sessions from August 2021 forward for details.
 - i) On November 23rd, 2021, the County engineer prepared grant applications:
 - (1) The Twp was awarded a grant of \$175k for the reconstruction of Ginter Rd. (joint project with the City of Defiance).
 - (a) The fund line in the UAN system has been set up and the award/grant has been posted to the fund.
 - ii) As of this session:
 - (1) The money is appropriated as the project is to take place in 2023.
 - (2) The Trustees are utilizing the County Engineer as project coordinator.
 - (3) The County Engineer is working with the City of Defiance preparing bid specs.
 - (4) The chair asks for any discussion?

- c) Bank Depository for township funds is presently the State Bank and Trust.
 - i) Said agreement was renewed by the Trustees on January 23rd, 2018 and is in effect from November 24th, 2017 to November 25th, 2022.
 - (1) The agreement pledges the bank's assets to cover the Twp funds which are on deposit at this institution.
 - (2) The bank per agreement is matching the Star Ohio interest rate on the money market account (investment account).
 - (3) The agreement is due for renewal.
 - (4) **Exhibit 3-j** is the draft agreement and the Prosecutor's review email for Trustee review and signatures.
 - (a) Trustees signed the agreement and directed the fiscal officer to email a copy to the State Bank.
 - g) February bills through the 27th, Trustees Review Discussion and Signature.
 - h) Payroll & February time cards (time cards provided trustees prior to session) Trustees Review Discussion and Signature.
