The Defiance Township Trustees met in regular session at the Defiance County Commissioners building – 2nd Floor conference room, 500 Court Street, in Defiance Township, Defiance, Ohio, on Tuesday, August 24th, 2021 at 6:30 p.m. Answering as present were Dan Peck, Diane Mayer & Jason Shaffer, with all three (3) members of the BOARD OF TRUSTEES having answered the roll, a quorum was declared.

 - a) The Reconciliation for July noted a primary checking reconciliation balance of \$348,413.39-- balance is minus the outstanding checks and Township investment funds & is taken from the Bank's monthly statement.
 - b) Receipt report:
 - i) Receipts for August (UAN software-) were \$19,306.73.
 - c) Payment reports:
 - i) Payments for August (UAN software-) were \$30,162.59.
 - d) The Cash fund summary through- August 22nd, 2021, (UAN software) showed an "ending fund balance" of \$1,073,203.76.

i) The "cash available" for encumbrances (unencumbered fund balance- UAN software) was \$635,324.45.

- e) Appropriation Status showed that through August 22nd, 2021 (UAN software), 17% of the years' appropriations had been expended. All reports will be on file in the Fiscal Officer's office.

- a) Audit of Twp funds for years 2019 and 2020.
 - i) State Auditor is Deb Mack
 - ii) Audit is AUP est cost is \$2,700
 - iii) **Exhibit 3-i** is a notice from State Auditor that the audit is final and has been posted to the Auditor's website also there is a copy of the audit report.

(1) The audit notes the Twp should post its public records policy on the Twp web page & and that a

retention policy should be filed with the state of Ohio.

- iv) The Chair asked if there are any comments, questions?

- v) The fiscal officer reported that the Twp awaits final billing.
- vi) This item will be removed from future agendas.
- b) American Rescue Plan Act Def. Twp application
 - i) **Exhibit 3-j** is notice from the Ohio Office of Budget and Management (OBM) of the grant award to Defiance Twp.
 - (1) OBM is managing the grants for many of Ohio's political subdivisions.
 - (2) The Def. Twp award is for \$176,505.54
 - (3) This will be distributed in two payments.
 - (4) A SAMS number must be acquired by the Twp (in progress)
 - (a) This is to provide required quarterly reporting to the US Treasury.
 - (5) The fiscal officer is still researching allowable expenses.
 - ii) The Chair asked for discussion..
 - (1) There was none.
- c) The fiscal officer reported that the Twp has received from the Def Co Auditor's office the 2022 anticipated and approved amount the Twp is to receive from the County's General Property tax receipts & the Twp's fire levy. These amounts are to fund the Twp's Gen fund, fire fund & Road and Bridge Fund. The notice estimates the amount the Twp can expect from Inside the 10 mill limitation and from outside the 10 mill limitation (see schedule A of the resolution.)

i) The Twp can expect to receive a total for both the general fund and road and bridge (road funds) of \$115,000.00 from the inside millage in 2022. This is roughly a \$10k increase from the amount projected to be received in 2021.

ii) The fire levy (fire combat/ems service levies) (outside millage) will receive a projected \$124,100.00 – This is approximately \$1,400.00 more than projected in 2021.

 - (i) In April 2021 Trustees had hired A Cut Above tree service of Defiance to address the project.
 - (a) July update:

 - (2) At the June 22nd session it was noted by Railing that tree branches were hanging over the road at

Garman and Krouse.

- (a) Buchholtz and Railing were to check and determine if they can trim back. If not then Trustees will contact the Co. Engineer's for assistance on this issue.

 - (a) Co. Engineer is present to update:
 - (b) Mr. Schlatter asked City Engineer Melinda Sprow to comment. Ms. Sprow presented a proposed Project construction cooperation Agreement for the Trustees to review. This agreement proposes to:
 - (i) share in the expense of reconstruction of Ginter road from the Twp's portion starting at the corner of Carter road to the end of the road at the intersection of State route 66.
 - 1. Mr. Schlatter said that the Twp will use its OPWC grant funds and will need to pledged a commitment of \$81,148.24 in cash from its road accounts.
 - 2. this is for road reconstruction only the City has agreed to pay for the proposed sidewalk-bike path.
 - **3.** Per the Co. Engineer the Twp is responsible for 40% of the road and is being asked to pay for that percent of the road construction work.
 - 4. The agreement prints out a summary of the work to be preformed.
 - (ii) Schlatter stated that the OPWC grant application will be made in 2021, the award will be made in 2022 and the construction will begin in 2023.
 - Mr. Shaffer requested a motion to accept the Ginter rd cooperation construction agreement.

- e) Ginter rd maintenance 2021
 - i) In August Trustees were told that the City had patched their side of Ginter Rd. The Twp was provided data from the City showing that the Twp is responsible for the north side of the two lane road from the woods of the Boy Scout camp starting just west of the city subdivision near Chinook Dr proceeding westerly to Carter Rd.
 - (1) Refer to **exhibit 6-e-1** an email forwarded from Diane Mayer to Trustees, the email contains the city email to Diane regarding the city's understanding of area of responsibility and an email from the Co. Engineer noting his understanding of the area of responsibility. Both reflect the description in d-i above.
 - ii) **Exhibit 6-e-2** is a quote from the Def. Co. Engineer's office on the price to patch Ginter on the Twp side of the road. It is possible to do this yet in 2021.

- (1) Discussion County Engineer Warren Schlatter:
- (2) Schlatter noted that the road is in need of repairs and recommends the patching. He stated that when the road reconstruction takes place this material will be ground up and used in the reconstruction.
- (3) The exhibit notes an estimated cost of \$10,318.07 for seven patches.

 - (b) Defiance County Engineer Warren Schlatter...noted this proposal is his with the City and has worked well.
 - (c) Trustees took the proposal under advisement.
- f) Defiance Paulding Co. Line Rd. 10 maintenance agreement w Auglaize Twp, Paulding, Co.
 - At the June Twp session the fiscal officer stated that the Paulding Co. Auglaize Twp fiscal officer and asked if Def. Twp. had documentation of a maintenance agreement between Auglaize Twp. and Def; Twp. regarding the Twp section of Def. Co. Line Rd. 10.
 - (1) Def. Twp. has no such agreement on file.
 - (2) Auglaize Twp Trustees wish to discuss a drainage issue and other possible maintenance items such as snow removal and mowing.
 - (1) At the July session:
 - (a) Auglaize Trustee Widenhammer stated there is presently a drainage issue on this road and that Auglaize twp has been mowing both sides of the road.
 - (b) Def. Twp noted its operators have also mowed and plowed both sides of the road.
 - (c) the Auglaize Trustees state that it might be beneficial if there was a written agreement which would state the responsibilities of each Twp on what portion and what types of maintenance would be done.
 - (d) All Trustees of Auglaize and Defiance Township agreed that a written maintenance agreement was desirable. Further, all Trustees agreed that Auglaize Twp Trustees would have such an agreement prepared by their County Prosecutor. The agreement would be provided to Defiance Twp Trustees and Def. Trustees stated that they would have the Defiance Co. Prosecutor review.
 - (e) If Defiance Twp desired edits to the Auglaize document these edits would be made and the revised document would be sent to the Auglaize Trustees for review and comments.
 - ii) August update:
 - (1) Exhibit 6-F is the draft maintenance agreement received from Auglaize Twp as prepared by the Paulding Co. Prosecutor.
 - (i) Def. Co. Engineer Warren Schlatter was provided a copy as directed by Defiance Twp. Trustees to seek his input.
 - (ii) Discussion Co. Engineer Warren Schlatter stated the agreement could work as presented, however, it might be better to just accept all responsibility for the section of road to be maintained by each Twp, accept for road reconstruction which should be reviewed by both parties.
 - (iii) Edits were made which proposes that each Twp be responsible for all road maintenance accept for road reconstruction and ditch maintenance. The edited draft will be submitted to Auglaize Twp. for their review and comments.
- g) Trustee Shaffer noted that both Krouse and Ball roads need repairs (patching) due to the wear and tear from large trucks going to the landfill.
 - i) Trustees agreed to speak with the County Engineer (he had left for another session prior to this issue), Trustees hope to have the engineer's office address this yet this fall.

h) 2021 financial impact review by the fiscal officer:

- i) The fiscal officer reported:
 - (1) Total road fund revenues year date are
 - (2) Total road fund expenses year to date are
 - (a) Road salt purchased 2021– total \$5,460
- ii) Anticipated road funds revenue for 2021 based on the January 8th, 2021 1st Twp amended certificate was:
 - (1) \$208,350 more or less
- iii) Anticipated expenses for 2021 as of this session:
 - (1) Regular twp. expenses anticipated for the year, baring emergencies. The estimate for 2021 based on historical review, is placed at between \$70,000 and <u>\$100,000</u> – would include Twp projects estimated or completed so far this year.:
 - (2) <u>\$48k</u> as of this session for Co Eng work- in 2021 refer to item 6-1 of the April 2021 agenda (other than Bowman Rd. rebuild).
 - (3) \$120,250 refer to exhibit 6-1 of this session Bowman Rd. rebuild -

 - (a) Ginter rd patching co. eng. Est \$10,318 more or less.
 - (b) The anticipated spread of expenses remains the same as of this session.
 - (5) savings towards the Carter/Ginter rd project- project cost to Twp is remaining OPWC grants and \$81,148.24 cash anticipated to be expended in 2023.
 - (a) it is anticipated that 40k per year will be earmarked in 2022 and 2023.

- A recap of the OPWC grants see minutes of previous sessions for history. An update was last received from the Co Engineer's Office dated 01-07-2021 (exhibit 6-f) part of annual public officials meeting held in Feb.
 - i) Current status as reported by the fiscal officer
 - (1) –OPWC grant work for 2021- no known activity as of this session.
 - (a) The amount of OPWC grant funds spent on the Twp's behalf in 2021 –none as of this session.
 - (b) The amount of funds for Twp. use is \$52,332.42 plus remaining grants over the next 4 years.
 - (c) <u>Trustees are reminded that there is no longer a discount in effect from the Co. Engineer for work</u> done on the Twp's behalf by Engineer staff. Use of funds is 100%.
 - ii) The Engineer had previously informed the Trustees that with the passage of issue 1 several years ago the law promises the grants. The average annual grant for Def Twp. is \$25k for the next 4 years or a total of \$100k remaining give or take.
 - iii) As of this session:
 - (1) Trustees have committed all OPWC grant funds for the Twp's portion of the Ginter rd project noted above.
- j) Trustee Mayer noted that in this months edition of the Twp newsletter "Grassroots" a grant for road projects was available.
 - i) Trustees decided to contact the County Engineer to seek assistance in applying for this grant.
- k) The Chair asked if there was any other discussion regarding the fiscal impact report or other road issues?i) There was none.
